- 3- or 5gang manifold with holding plate for easy and secure attachment to the IV pole with a special clamp. They are transparent, lipid resistant and pressure resistant till 1.5 bar. Handles are with different colors to differentiate the monitoring lines.

General notes:

- · Read carefully instructions before using.
- The product may be shown commitment only according to the described dedication. The application of the product only may be carried out of a qualified doctor or under his instruction.

Gravity use

All our stopcocks and manifolds have 6% Luer Lock connections in order to be easily connected to the others devices.

Return

Prior to the return of a product due to a quality complain, you must decontaminate it and add to your delivery the corresponding decontamination certificate.

In the absence of this certificate, your complain will be automatically rejected and the related product immediately destroyed.

Other notes:

Do not allow to the catheter to come into contact with acetone and disinfectant agents, as this can weaken the material or cause leaking or air aspiration.
